ISBE Issues New Proposed Regulations Regarding Highly Qualified Teachers--On October 26, 2005, ISBE issued new proposed regulations addressing the criteria teachers must meet to be considered highly qualified. The regulations affect regular and special education teachers, as well as bilingual teachers and charter school teachers. Aside from setting forth the new criteria, there are two notable items in the proposed regulations. First, the regulations make clear that the requirement for teachers to be highly qualified applies only to teachers with the *primary responsibility* for instructing students in core academic subject areas. Accordingly, a teacher who collaborates or consults with another teacher does not have

"primary responsibility" and does not have to be highly qualified. Second, the regulations define "veteran teacher" as any teacher who has accrued one full year of teaching experience. Previously, a veteran teacher was defined as any teacher who was first certificated in Illinois on or before June 30, 2002. This change is significant in that veteran teachers have access to the HOUSSE system to determine if they are highly qualified. "New teachers" as defined under the new proposed regulations, do not have access to the HOUSSE system to prove their qualifications.

TRS Submits Proposed Rules Implementing New Pension Laws to JCAR -- TRS submitted proposed rules implementing the new pension reforms contained in [P.A. 94-0004](#) to the Joint Committee on Administrative Rules ("JCAR"). The proposed rules were published in the Illinois Register on October 7, 2005. Under the administrative rulemaking process, following their publication, there is a 45-day period for public comment on proposed rules.

The proposed rules define the term "normal annual sick leave allotment" and set forth the required employer calculations for granting sick leave days in ex-

cess of the normal annual sick leave allotment and for granting certain salary increases in excess of 6%. Additionally, the proposed rules address a number of transitional issues involving impermissible modifications to "grandfathered" contracts or collective bargaining agreements, retirement incentives paid and sick leave days granted after the "grandfathered" contract or collective bargaining agreement expires and the "grandfathered" status of employment policies.

Illinois Department of Public Health Adopts Final Regulations Addressing AEDs in Physical Fitness Facilities--

The Illinois Department of Public Health has adopted final regulations implementing the [Physical Fitness Facility Medical Emergency Preparedness Act](#), 210 ILCS 74/1 et seq. ("the Act"). These final regulations differ in several important ways from the proposed regulations published this spring. First, unlike the proposed regulations, the final rules require school districts and other owners/operators of physical fitness facilities to have at least one trained user *on staff*, rather than *on the premises during facility operation*. Second, acts that will constitute violations of the Act have been amended to parallel the above-revised requirement. Finally, and most importantly, the final regulations require that a third-party user simply be informed of the AED and medical emergency plan. They remove the requirement that a facility operator or third party user of a facility ensure that a trained AED user is on the premises during the third party's use when third party user will employ people to supervise, instruct, train or assist others

using the facility for physical fitness activities, will be supervising a total of 100 or more individuals at the facility, and will use the facility for physical fitness activities focusing primarily on cardiovascular exertion.

The final regulations retain the same required components of a medical emergency plan as described in the proposed rules. Your district's medical emergency plan was required to be on file with the Department by July 1, 2005.
